



Supplementary Regulations

1. AUTHORITY

The event shall be held under the International Sporting Code of the FIA, the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the CAMS Motor Sport Passenger Ride Activity (MSPRA) Policy, the Speed Event Standing Regulations, the Regularity Trial Standing Regulations, these Supplementary Regulations and any other Further Regulations or instructions which may be issued, and will be subject to CAMS Permit Number **718/2005/01**.

The event will be conducted under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at www.cams.com.au

2. EVENT DESCRIPTION AND OPERATION

The Light Car Club of Tasmania will be conducting a **Multi-Club Regularity Trial** (herein referred to the as "the event") on 20/05/2018 at Symmons Plains Raceway over a lap distance of 2.41km.

The event will consist of:

- Competitors are invited to participate in a Parade with a Passenger allowed. Particular attention is drawn to the Parade section of these regulations for the conduct of this session.
- Competitors are invited to enter Teams of between 3 and 6 drivers, drivers may share vehicles or compete in separate vehicles.
- A 1 hour timed practice session for all competitors, at no time during this session may more than one member of each team be on the circuit.
- A 4 hour competition session during which each team must complete 180 timed laps. Any team failing to complete the required laps in the allotted 4 hours will be deemed to not have finished the event. No team will have any more than their first 180 completed laps included in their results.
- As per the CAMS Track Licence, there will be a maximum of 32 cars on the circuit at any time during competition.
- The event will commence at 10 am and finish at 5 pm.
- The minimum lap time for the field will be 65 seconds. (Refer Article 4 Regularity Trial Standing Regulations)
- For the reference of competitors 130% of the minimum is 84.5 seconds. (Refer Article 5 Regularity Trial Standing Regulations)
- On-Track immobilisation. The organisers envisage the use of a red flag to cease competition while immobilised vehicles are returned to the paddock, this will reduce the impact of such time on each teams results.
- Pit lane speed limit. At all times the Pit Lane Speed Limit will be 40km/h.
- Paddock speed limit. At all times the Paddock Speed Limit will be 10km/h – i.e. walking pace.
- Refuelling Procedure:
 - Refuelling may only take place within the fenced area of the Scrutiny Bay.
 - Those persons refuelling a car must be dressed to at least the same standard as vehicle drivers – ie, non-flammable covering from neck to wrist to ankles. It is highly recommended that overalls to FIA 8856-2000 or 1986 or SFI 3.2A/1, or PPE to AS/NZS ISO 2801:2008 are worn when refuelling vehicles.
 - Each team must provide at least 2 x 0.9kg fire extinguisher as part of their refuelling equipment. This must be readily accessible adjacent to the refuelling area at all times open fuel containers are present.
 - Vehicles exiting the track and requiring refuelling will proceed along pit lane from their garage and drive through garage 5 directly to the Scrutiny Bay.
- Competition Numbers Each Team will be notified in advance of their Team Number and Driver Alpha Identification. It is the responsibility of the Team to supply its own number and alpha decals as per the Diagram A below. The number and alpha decals are required to be displayed on both sides of your car and on the front passenger side of the windscreen.

Please note: There must be only one set of numbers & alphas displayed on the vehicle at any time and this number & alpha must correspond to the driver & Westhold combination. If sharing a vehicle, only one number & alpha may be displayed on the vehicle at any time, in compliance with Diagram A above. Vehicles displaying two numbers will be black flagged.



Supplementary Regulations

- Scoring
 - For each lap on which the competitor records a lap time less than their nominated time minus half a second, a penalty of two (2) points per half second will be applied.
 - For each lap greater than their nominated lap time plus half a second, a penalty of one (1) point per half second will be applied.

6. ENTRIES

Entries may be made via the CAMS Event Entry system at <https://www.meecamsau.com> Credit Card Payments before the event will be accepted via CAMS Event Entry. Cheques and Money Orders should be made payable to LCCT. Entries shall be directed to the Event Secretary at the above address. Entries paid by Cheque are not contractual until the Cheque is honored. Credit and Debit Card payments can be accepted on the day.

7. DOCUMENTATION AND SCRUTINY

Documentation and Scrutiny will commence in the Scrutiny Bay at 9.00 am on the day of the event. All cars must attend and pass Scrutiny prior to the Event. Current Club Membership Cards, CAMS Speed/Speed Junior (formerly Level 2S) or superior licence, competition record and helmet must be presented at Scrutiny. Cars must be presented at Scrutiny with log book (if issued) in track ready condition.

8. DRIVERS BRIEFING

Drivers Briefing will commence at 10.30 am on the day of the event. All Competitors are to attend the compulsory Briefing. Failure to attend this Briefing may result in the Competitors being fined \$500 or being excluded from the Event and the forfeiture of any Entry Fee.

The promoter reserves the right to refuse entry in accordance with NCR 83.

10. CLASSES

Class A, B, C, D, E and F.

- A. Cars of capacity up to 1600cc
- B. Cars of capacity 1601 – 2000cc and super/turbo charged cars of capacity up to 1600cc
- C. Rotary or 6 Cylinder cars and super/turbo charged cars of capacity 1601 – 2000cc
- D. 8 or more Cylinder cars and super/turbo charged Rotary or 6 Cylinder cars
- E. Cars using slick tyres
- F. Clubman and Formula Libre type vehicles of any capacity.

Note:

The organisers may re-classify any vehicle if they believe it is not eligible for the class in which it has been entered. Any class that attracts less than three (3) competitors may be amalgamated with other classes at the discretion of the organisers.

11. TYRES

Grooved Tyres

Tyres that have been grooved after manufacture, or have been regrooved, are not permitted to be used.

i. Tyres Banned

Tyres marked "For racing Purposes Only" or "Not for Highway Use" (or similar) are prohibited. Note that this specifically precludes the use of slick tyres. Any competitor using such tyres will be placed in non-competitive class E.

ii. Organisers Rights

The organisers reserve the right to prohibit tyres at any time before or during the Event. All tyres to be used in competition are to be presented at scrutiny, and may be marked by the scrutineers.

12. PRIZES AND TROPHIES

The following prizes, trophies and series points shall be awarded at the discretion of the Promoters:

- Club points for LCCT Members.
- Trophies as provided by the event sponsors.

13. TIMING, WESTHOLD TIMING TRANSMITTERS AND RESULTS

Timing will be by the Natsoft Race Timing System and will require the use of Westhold Timing Transmitter. Detailed and live results will be available during the event at <http://racing.natsoft.com.au/results/>. The Clerk of Course, Event Secretary and Chief Timekeeper are deemed Judges of Fact.

14. ORGANISERS AND CAMS DECALS

The Organisers may provide an Event Sponsor Decal which must be fitted as instructed by the Organisers. In addition, the CAMS State Office may provide CAMS Decals, these are to be fitted as requested.

15. INSURANCE

Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

Competitors involved in incidents which result in claims to rectify property damage under the CAMS Insurance Policy are required to pay the excess for each incident. The excess for this event is documented in the CAMS Insurance Program 2017-2018 Handbook and is currently \$1,000. If the cost is less than the excess competitors will only be required to pay the cost of rectification.

In relation to the CAMS Personal Accident Insurance Competitors are reminded that, by Commonwealth Legislation, it is not possible for any insurance to pay the gap between the Medicare reimbursement and the actual cost of the health care received. "The Health Insurance Act 1973 (Cth) prohibits general insurers from covering any item listed within the Medicare Benefits Schedule (MBS)." If you are taken to hospital you will be asked "is this injury covered by insurance?" or such similar question. You (or your carer, as may be appropriate at the time) must be very specific and advise the hospital that the injury is NOT a workers compensation injury and that you are a public patient (or a private patient if you have private health care and wish to avail yourself of it). Remember that the MAIB Compulsory Third Party Insurance does not provide cover for injuries occurring during competition.

16. PROTEST

Any protest must be lodged in accordance with Part XII of the NCR.

17. ABANDONMENT, ALTERATION & SUSPENSION

The Promoters reserve the right to abandon, cancel, alter or postpone the event in accordance with NCR 59 or to temporarily suspend the Event for any reason.

18. DRIVERS

All Competitors and Drivers must hold a current CAMS Speed Licence (formerly Level 2S) or superior and be a member of a CAMS Affiliated Club. One passenger, who may not be a member of the Drivers' immediate family, may be permitted in each car during the Parade. Passengers must sign the appropriate indemnity before the car leaves the Pit Lane. The vehicle must also be kept to less than competition speeds.

19. PARADE – refer NCR 20a

A parade is a display of a group of cars at moderate speed, arranged as entertainment of spectators, or as a commercial display.

- An official car will lead the Parade and another will close it.
- The Parade shall have a maximum speed of 70km/h.
- Each of these Official Cars shall be driven by an experienced driver who shall be under the control of the Clerk of Course.
- Overtaking is strictly forbidden.
- Timing is forbidden.
- All Drivers and Passengers must be seated and wearing a properly fitted seat belt, in addition, they must be attired to the same standard as required for competition in the Event as detailed below.
- Drivers must not allow a space to open up between cars.
- Drivers, who have entered the Event, are permitted to participate in the Parade.
- Passengers must sign the appropriate indemnity before the car leaves the Pit Lane. Note, this will be collected by an official at Pit Exit as the car enters the track.

20. MOTOR SPORT PASSENGER RIDE ACTIVITY

At the discretion of the event organisers, and subject to being arranged with the Event Organisers before the event, a Motor Sport Passenger Ride Activity (MSPRA) may be held. Particular attention is drawn to the Motor Sport Passenger Ride Activity section of these regulations for the conduct of this session:

- The Driver and vehicle must be entered for the event.
- Drivers and Passengers will be required to attend a specific briefing from the Clerk of Course before participating in this session. Note that the Driver and Passenger must agree on an abort procedure.
- Vehicles participating in the session must undergo scrutiny by the Chief Scrutineer.
- Before a Passenger will be permitted in a MSPRA the Driver must complete at least one lap of the circuit driving the subject Vehicle.
- The MSPRA must always be conducted comfortably and clearly within the limits of the Vehicle and its Driver and at significantly less than normal competition speed.
- Timing is forbidden.
- Overtaking is not permitted.
- All Drivers and Passengers must be seated and wearing a properly fitted safety harness, in addition, they must be attired to the same standard as required for competition in the event as detailed in these Supplementary Regulations.
- Passengers must sign the appropriate indemnity before the car leaves the Pit Lane. Note, this will be collected by an official at Pit Exit as the car enters the track.
- The full MSPRA Policy is available on the CAMS website and will be available for inspection at the Event. This policy will be the exclusive reference for the session.

21. ALCOHOL, DRUGS AND OTHER SUBSTANCES

Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

22. CODE OF DRIVING STANDARD FOR COMPETITION

It is the responsibility of all drivers to drive in a manner to reduce the risk of accidents and be considerate of other competitors and their investment in their cars.



Supplementary Regulations

The following is expected of all drivers:

- (a) Drivers must remain on the circuit proper at all times. When passing other competitors you are to ensure all four wheels remain on the circuit proper whilst doing so. (I.e. Using the grass or verge of the circuit is NOT acceptable)
- (b) Driving down the centre of the circuit with the aim to prevent overtaking is not acceptable. There is generally one fast line around any circuit ('Race Line'). For any competitor to deviate from this line should only be to overtake another car or avoid debris on the circuit. To deviate from this line to make it difficult for other competitors to pass is 'Blocking' and is NOT acceptable.
- (c) When approaching a corner, a competitor may change direction to select the side of the track they are using ONCE, a further change of direction, or to weave, is considered Blocking and is not acceptable. It is a dangerous tactic to use and will most likely result in damage to one or more cars.
- (d) When being passed by another competitor squeezing them over to the verge, so they run off the circuit proper, is NOT acceptable.
- (e) When about to pass another competitor into a corner, ensure you are far enough alongside before the apex of the corner, so he/she are well aware of your presence and intent to pass. The competitor being passed must give racing room.
- (f) Driving down the inside at the corner apex, where the only way to pass is to bounce off another competitor is NOT acceptable.
- (g) When a faster car is approaching from behind, you are to keep to your standard racing line, the other car must choose the correct passing opportunity, you must NOT hinder that car. Both cars must be respectful and provide racing room.
- (h) If you can't pass safely, wait for another opportunity to do so.
- (i) If an incident occurs, NEVER abuse or lay hands on another competitor regardless of how aggrieved you may feel. This is totally unacceptable. Allow some time to pass before approaching the other competitor involved (cool down period).
- (j) If you happen to go off the circuit do NOT re-enter without first ensuring you can do so safely.
- (k) Motor racing is a highly competitive and exciting sport and sometimes accidents will happen, resulting at times in damage to vehicles however, these incidents can be minimised if all competitors follow the above 10 points.

23. VEHICLE EQUIPMENT & SAFETY

All vehicles, Drivers and Passengers must comply with CAMS General Requirements for Cars and Drivers applicable to multi-start speed events. <http://www.cams.com.au/motor-sport/regulations/cams-manual/general-requirements>. Competitors should note that compliance with Schedules A and B is mandatory in multi-start speed events. It is also recommended that Competitors utilise Schedule C as a guide to vehicle preparation.

(a) Apparel

Drivers and passengers must be attired in long legged trousers and long sleeved shirts or tops made of a non-flammable material. Suitable footwear is required (no thongs, sandals or high heeled boots/shoes.) Drivers and passengers must wear a helmet, which complies with AS 1698 (or as otherwise listed in Schedule D of the current CAMS Manual of Motor Sport) at all times whilst on the track.

(b) Safety cage

A Safety Cage Structure in accordance with Schedule J of the current CAMS Manual of Motor Sport is required for 1st Category (open wheel racing cars) for this event; they are not required for other vehicles although the Organisers strongly recommend that they be fitted to all vehicles. Competitors with Safety Cage Structures built to previous or foreign regulations are referred to Article 4 of Schedule J of the current CAMS Manual of Motor Sport.

(c) Safety harness

Must be fitted with a safety harness of a type listed in Schedule I of the current CAMS Manual of Motor Sport (i.e. AS2596, ADR 4/00 or 4/01, AS E35, SFI 16.1, FIA Standard 8853/98, 8853-1985, 8854-1991 or 8854/98 or European Standard ECE R16). Competitors are reminded that where required by the relevant standard (FIA 8853/98, 8854/98, SFI16.1), seat belts need to comply with CAMS age requirements.

(d) Fire extinguisher

Must be fitted with a fire extinguisher of at least 900g capacity, which complies with Schedule H of the CAMS current Manual of Motor Sport properly fitted at a suitable location. Extinguishers will be inspected by Scrutineers before the event as per Schedule H. It is highly recommended that the extinguisher be presented with a current inspection tag.

(e) Tyres

Tyres in accordance with Schedule E of the current CAMS Manual of Motor Sport must be used and must be in roadworthy condition. Retread tyres will not be permitted.

(f) Fuel

Only Commercial or Racing Fuel in accordance with Schedule G of the current CAMS Manual of Motor Sport may be used.

(g) Bonnet restraints

All vehicles must be fitted with 2 separate fasteners on any front opening panel (e.g. Bonnet), as per Schedule B of the current CAMS Manual of Motor Sport.

(h) Tail shaft straps

Any car that is not road registered shall be so constructed that any longitudinal propeller shaft shall be protected from striking the ground, this requirement is strongly recommended for road registered cars, as per Schedule B of the current CAMS Manual of Motor Sport.

(i) Throttle springs

Be fitted with a return mechanism which in the event of any throttle linkage failure will close each throttle, as per Schedule B of the current CAMS Manual of Motor Sport.

(j) Noise

All vehicles shall be configured such that the sound emitted when measured 30m from the track edge does not exceed 95dB(A) as per Schedule B of the current CAMS Manual of Motor Sport.

(k) Oil Catch Tank

Any vehicle that is not road registered and is fitted with any crankcase breather discharging to the atmosphere shall be fitted with a Catch Tank as per Schedule B of the current CAMS Manual of Motor Sport.

(l) Engine Radiator Catch Tank

Vehicles fitted with engine radiator cooling vent discharging to the atmosphere shall be fitted with a Catch Tank as per Schedule B of the current CAMS Manual of Motor Sport.

(m) Headlight glass

All vehicles must have all forward facing glass, except for the windscreen, covered with an adhesive film, as per Schedule B of the current CAMS Manual of Motor Sport.

(n) Battery location

Display a blue triangle with sides of 150mm on the coachwork indicating the location of the battery, as per Schedule B of the current CAMS Manual of Motor Sport. If the battery is installed within the vehicle cabin it must be secured in an insulated container and vented to the exterior of the car.

(o) On-Board Cameras.

A camera is not permitted unless fixed by a suitable secondary restraint to a secondary anchor point that is able to withstand a force of 25g. Cameras when suspended only by their secondary restraint must not hit the ground, vehicles wheels, vehicles controls or the driver. A Scrutineer must approve all camera fitments.

(p) On track breakdowns

Any car immobilised on the course will be removed by the Organisers and may be subject to Scrutiny (at the discretion of the Clerk of Course) before being allowed back on the track. At no time shall a driver undertake mechanical repairs while an Event is in progress.

(q) Loose objects

All unsecured objects including jacks, spare wheels, floor mats etc. must be removed from the vehicle cabin, console and boot.
